The following represents a complete description of membership types and fees for the 2017 season in accordance with the club's rules and regulations.

FAMILY

A family membership consists of a co-habiting couple, their dependent children under 21 years of age, babysitters, nannies, and au pairs. Initiation Fee \$1390 (can be divided into 2 installments), Annual Dues \$750 by April 8th, and \$800 after April 8th, Reinstatement Fee \$400.

ADULT

An adult membership consists of 1 or 2 individuals in a household who are 21 years or older, and who have no dependent children living in the household. Initiation Fee \$560 (1 installment only), Annual Dues \$400 by April 8th, and \$450 after April 8th, Reinstatement Fee \$200.

SENIOR

A senior membership consists of 1 or 2 individuals in a household where at least one is 65 years or older, and who have no dependent children living in the household. Initiation Fee \$400 (1 installment only), Annual Dues \$300 by April 8th and \$350 after April 8th. Reinstatement Fee \$100.

TENNIS ONLY

A tennis only membership consists of 1 or 2 individuals in a household who are 21 years or older.

2 individuals: Initiation Fee \$300 (1 installment only), Annual Dues \$250, Reinstatement Fee \$100.

1 individuals: Initiation Fee \$200 (1 installment only), Annual Dues \$150, Reinstatement Fee \$100.

TENNIS KEY ACCESS

We have new locks as of last season, 2016. Therefore, if you did not purchase a key last year and would like to have access to the tennis courts after hours, please purchase a key for \$25.

FAMILY LIFETIME

A family lifetime membership consists of a co-habiting couple and their dependent children under 21 years of age. This membership class entitles the owner(s) to a lifetime of free attendance at the club, keys to the courts and ball machines, and exclusion from future assessments. Cost \$9,750 (can be divided into 3 installments). No annual dues, and no reinstatement fees.

ADULT LIFETIME

An adult lifetime membership consists of 1 or 2 individuals in a household who are 21 years or older, and who have no dependent children living in the household. This membership class entitles the owner(s) to a lifetime of free attendance at the club, keys to the courts and ball machines, and exclusion from future assessments. Cost \$3,900 (can be divided into 3 installments). No annual dues, and no reinstatement fees.

Reinstatement Fee

Members may suspend their membership for an indefinite amount of time but must pay a reinstatement fee to become active members again. Reinstatement fees vary depending on the type of membership.

Guest Policy

Guests must be accompanied by a member. Guests living farther than 50 miles from the club, house guests, nannies, babysitters, and au pairs are free. Local guests cost \$5 per person per visit, or the use of a prepaid guest pass which is on record at the front desk. Each local guest may visit up to 2 times per month. Every guest must sign a waiver of liability which is available for download from the club website.

If the guest is under the age of 18, the waiver can only be signed by the child's parent/legal guardian. Waivers will be kept on record at the front desk for the duration of the season. A limited number of prepaid guest passes may be purchased prior to Opening Day via the club website.
